The annual ECTUN Conference in Madrid in November 2024, decided the setup of a Working Group to examine the rise of the far right in European Capitals and Regions, the impact on labor and the actions of the trade unions to face this threat.

Pressure, labelling, bullying of an individual are present if they publish some socially relevant content.

Joint action would be a pressure on the existing ruling structures, that the human being - the worker is in the foreground and to reduce the gap between the interests of capital and the interests of ordinary people.

National Parliamentary elections held on 18 May 2025, CHEGA Got 22.76% (1,442,194 votes) elected 60 MPs, making it the second largest political force in parliament

Among many things, they exploited the alleged lack of security, blaming the migrants for the situation. Although official data contradicted them, they persisted in their lies. They also accused migrants of draining the resources of the national health service, and of draining the resources of social security, saying that they came to the country only to earn benefits without working. A lie that also made its way although official data also denied them.

The anti-corruption discourse remained central, associating the image of figures from the two largest parties and a banker in court, but also associating 50 years of democracy with corruption. The discourse against what it calls 'gender ideology' and against what it calls 'socialism'.

Another very present theme was that of justice, which he considers to be "soft", and the need for heavier sentences (chemical castration for paedophiles, life imprisonment, etc.).

### 5. What consequences on the existence and work of democratic trade unions do they have?

For the time being, there is a direct consequence, which has to do with the permeability of workers (including unionised workers) and some members of the structure who have assimilated his discourse, mistakenly believing that this party would have some solutions to the most immediate problems. However, we mustn't lose sight of the fact that in November 2022, Chega announced its intention to create a trade union centre, called 'Solidarity', according to the party's leader, along the lines of VOX in Spain.

It hasn't succeeded so far, but there are some professional groups that have been more permeable (notably the security forces and firefighters), and the hand of the far right can be seen behind some of the "spontaneous demonstrations")

#### 6. The role of the social media

This party dominates social media. They know the statistical workings of information distribution on these networks very well, as well as the algorithmic workings.

They have hundreds, if not thousands of fake profiles that are constantly spreading lies and hatred, rewriting history, and the lie circulates and becomes the truth for many people.

But also the media, which has given more prominence to this party and its leader than to any other party, and this has been happening since its formation in 2019, bears a lot of responsibility for this election result.

#### 7. Trade Union responses

#### At workplace

Our presence in the workplace is very important. We need to clarify and point out the contradictions of this party. It's also very important to help us reflect in order to combat the falsehoods and lies of the far right.

Trade unions have a very important role to play in contact with workers, contributing through their action in the workplace to the defence of democracy, the fight against hate speech, building and promoting the values of solidarity and unity among workers.

Plenaries with films to stimulate debate; the creation of moments with group dynamics that promote reflection, positioning and discussion on the issues that are on the agenda of the extreme right and that require a strong fight and clarification among workers can be some strategies to consider in this fight.

#### At community level

Contacting and carrying out joint actions with the associative movement, particularly with immigrant associations, but also with other associations and informal groups

The creation of events that promote enlightenment, the fight against hate speech, the values of democracy among the population (by the unions and together with other structures, associations, cultural workers).

Organising common actions and struggles against racism and xenophobia, among others.

### 8. Which policies failed in which areas and fuelled the rise of the far right in your capital/country?

Social policies have failed, wages are extremely low and cannot cope with the brutal increase in the cost of living, especially in basic necessities, energy and housing. Public services such as the National Health Service and public schools are deteriorating as a result of the neoliberal and right-wing policies of successive governments. People listen to messianic speeches and tend to believe that they have the solution to all the problems they face.

### 9. Common actions of ECTUN members as a roadblock to the onslaught of the far right

Sharing information and exchanging experiences, materials and actions between ECTUN unions on this issue can be an essential element in strengthening union action against the extreme right in capital cities.

#### At workplace

They tried to create a trade union but they have not been successful in the electoral processes in the companies, so we maintain the capacity to respond from the legal representation in the workplaces to combat their campaigns of disinformation and intoxication of the workforces.

#### At community level

All political and trade union forces, together with other social entities, respond to these kinds of attacks, but there is no single reaction. Normally, we do not respond publicly to their provocations, but we argue in the face of their outlandish proposals.

#### **Trade Union Agenda**

We continue with our agenda, which we believe is the best thing to do. We have held many awareness-raising conferences and campaigns, analysing in detail the impact of the extreme right from different points of view, but we focus on our proactive work and on defending the productive model, historical memory and democracy.

In 2021, the far right won approximately 13% of the vote in the first round of the regional elections. In the 2024 early legislative elections, the far right first round nationwide, and in the 2024 European elections, the far right won over 31% of the vote.

#### 2. Are they part of the government?

No, they are not officially part of the government.

#### 3. If yes, leading or partner?

Although the RN is not formally in government, it exercises significant influence on national policy, particularly at the level of the Ministry of the Interior on issues of immigration and security.

#### 4. Which were their main topics in the election campaigns?

The RN focused its campaigns on:

- Immigration: Drastic reduction of legal and illegal immigration
- Security: Strengthening law enforcement and combating crime
- National sovereignty: Opposition to certain EU policies

### 5. What consequences on the existence and work of democratic trade unions do they have?

The rise of the RN has raised concerns among unions:

- Stigmatization: Risk of marginalization of unions perceived as opposed to the RN's ideas
- Reduction of rights: Fears of a possible undermining of social gains and workers' rights

#### 6. The role of the social media

Social media played a crucial role in the rise of the National Rally (RN):

- Mobilization: Effective use to mobilize voters, especially young people
- Disinformation: Dissemination of simplistic and sometimes misleading messages to gain popularity

#### 7. Trade Union responses

UNSA is actively engaged in the fight against the far right, both in the workplace and at the community level.

#### At workplace

Education and awareness: UNSA Education has published a detailed guide to countering far-right ideas, providing arguments and resources to help activists deconstruct populist and xenophobic narratives. This guide is accompanied by educational videos with experts and trade unionists available on their YouTube channel.

Training of activists: Training sessions are organized to equip union representatives to deal with far-right discourse, particularly in the education sector where these ideas can influence school policies.

#### At community level

Inter-union mobilization: The UNSA collaborates with other unions such as the CGT and the CFDT to organize joint actions against the rise of the far right in France and Europe. For example, a meeting was held at the Paris Labor Exchange to coordinate a united union response to this threat.

Public positions: The UNSA publicly denounces the far right's attempts to exploit sensitive issues, such as birthright citizenship, to divide society. The union calls for vigilance against these political maneuvers.

#### **Trade Union Agenda**

Defense of Republican Values: The UNSA is committed to defending the principles of fraternity, solidarity, and democracy, firmly opposing the programs of the far right, which it considers dangerous for social cohesion.

Concrete Actions: The union organizes information campaigns, training sessions, and events to raise awareness among workers and the general public about the dangers of the far right and promote an inclusive society, such as a decryption guide or educational videos, demonstrations, dialogue with the authorities, clear political positioning, condemnation of all racist remarks, union charter excluding the opinions of political extremists and the inherent sanctions in the event of non-compliance.

Several factors contributed to the RN's rise:

Social inequalities: a sense of abandonment in some regions

Migration crisis: perceptions of ineffective immigration management

Distrust of elites: dissatisfaction with traditional parties

Major lack of interest among all politicians, leading to a loss of confidence and few voters to

oppose the RN

Large and growing role for the media to propagate their ideas

The Rassemblement National (RN), received 33.2% of the vote.

European elections - 9 June 2024

The RN received 31.5% of the vote, an unprecedented score for a French party at this scrutiny.

Île-de-France (whole region)

First round: RN obtained 16.41%

Paris: RN obtained 10.7% of the votes cast in Paris, compared with only 3.9% in 2022.

# 5. What consequences on the existence and work of democratic trade unions do they have?

The rise of the far right in France will have serious consequences for the existence, role and work of democratic trade unions, for a number of historical, political and institutional reasons. Here are the most important:

Delegitimisation: Rhetoric against 'left-wing', 'ideological' unions

Restriction of action: Fewer resources, less right to strike Division of workers: Nationalism and rejection of foreigners Weakening of social dialogue: Rejection of intermediary bodies. Possible resistance: Anti-fascist mobilisation, local anchoring.

#### 6. The role of the social media

Social networks are playing a central role in the rise of the far right in France - as a tool for communication, mobilisation and bypassing the traditional media. Here are the main dimensions of this role:

Bypassing the traditional media: Direct communication, without filters, mass dissemination of images and discourse.

Controlled and modernised image: De-diabolisation, young personalities.

Possible manipulation: Disinformation, misappropriation of facts.

Organised digital mobilisation: Effective campaigns, active communities.

#### 7. Trade Union responses

French democratic trade unions (CGT, CFDT, FSU, Solidaires, UNSA, etc.) have increasingly and explicitly taken a stance against the far right, especially since the rise of the RN and the Reconquête in the political and social arena. Here are the main forms of trade union response to this threat:

Public statements: Inter-union declarations 'Not one vote for the RN'.

Awareness-raising & education: Brochures, training, counter-arguments.

Mobilisation on the ground: Anti-fascist demonstrations, speeches.

Monitoring in companies: Fight against xenophobic comments, dialogue with employees. Defence of trade union freedoms: Reminder of the risk of authoritarianism and repression.

# 8. Which policies failed in which areas and fuelled the rise of the far right in your capital/country?

The rise of the far right in France, particularly visible in suburban and rural areas and even parts of the Paris region, is rooted in a number of structural political failures over the last 30 years.

Social policy: Declining public services, inequality. Feeling of abandonment, angry vote.

Security: Perceived laxity, unaddressed violence. Demand for authority, RN vote.

Immigration/integration: Ghettoization, lack of common project.

Rejection of the 'other', identity-based vote

Democracy: Crisis of confidence, abstention Anti-system vote.

Economy/expense: Precariousness, downgrading, housing RN perceived as 'close to the people'.

Paris and Ile-de-France: Although the majority of voters in inner Paris remain on the left, the RN

has grown strongly in the working-class suburbs (93, 95, 77) and the outer rural suburbs.

This rise reflects local failures combined with a loss of national bearings.

As in a growing number of countries, also in Austria the radical right is perceived as part of the political system in the form of a party. The movement character seems to be increasingly lost, and the extra-parliamentary apron and corresponding networks are also attributed to the dominant right-wing party. The extreme right is the largest parliamentary group and in many Austrian provinces ('Bundesländer') it is in the regional government. It therefore cannot currently influence all (federal) laws, but it can influence some – the legislation is in principle against the interests of workers and consumers, against environmental protection and social sustainability and protects capital (the party's major donors).

#### 6. The role of the social media

We see massive dominance of the far right on social media as a key reason for their power of discourse - Tik Tok is particularly problematic because it reaches very young people. In Austria the radical right has succeeded very well in establishing a closed factional media world with different channels. In addition, there are a number of private media houses (often family-owned) that cultivate correspondingly capital-friendly reporting and are helping to drive the dismantling of public media for their own profit interests. There's a clear shift in discourse to the right, presumably caused by digital dominance.

#### 7. Trade Union responses

The ÖGB is non-partisan, but takes a clear stance against right-wing extremist and antidemocratic forces. The ÖGB's responses on this topic are guided by the following principles, among others:

- 1. A clear stance against the right
- Right-wing politics divides and attacks our democracy. The ÖGB counters with values such as solidarity, equality and justice.
- 2. making democracy & co-determination visible

We show how democracy works in everyday life - for example through works councils and genuine co-determination in the workplace. They are the backbone of a fair world of work.

3. solidarity instead of division rights

We focus on cohesion. Our goal (and slogan): A good life for all - with fair work, fair transformation and social equalisation.

4. involve everyone

The ÖGB is not just a spokesperson, but a shaper. Members, works councillors and young people are actively involved - through educational work, participatory formats, street campaigns and everyday support.

5. solidarity - beyond borders

We stand for an EU based on solidarity. Nationalism is not the answer - international trade union work is.

Our mission in our trade union communication:

Setting positive counter-images

We show what we stand for under the slogans #DafürÖGB, #Zusammenhalten or #GemeinsamStark: Solidarity, justice and co-determination - instead of fear and division Works councils as democratic influencers: We support works councils with mailings, argumentation aids and tools - they are our 'democratic influencers' in the workplace.

Successful example: the ÖGB election check

With the ÖGB election check for the NR election 2024 (= online survey tool such as wahlkabine.at, but specifically tailored to trade union issues), we were able to expose right-wing anti-worker policies with a wide reach - fact-based and low-threshold:

- An online survey tool showed which parties are against the 6th holiday week or minimum wages, for example
- Personalised communication strengthened orientation
- Interactive social media formats mobilised broad target groups
- Our call to action at the time: 'Find out which party is on your side!'
  But it is also clear that fact-based communication alone is not enough. We need to engage people emotionally with our hearts and minds. Keyword: personalised storytelling!

### 8. Which policies failed in which areas and fuelled the rise of the far right in your capital/country?

The political left has been cowardly and did not stand up against Neoliberalism of the 1990s ff. and it allowed itself to become fragmented. It may has focussed on the wrong struggles, to be said on cultural struggle rather than class struggle. Another paradoxical problem is that the trade union and the democratic left were very strong for a long time and therefore experienced a certain degree of bureaucratisation. We need to learn how to be a movement again.

### 9. Common actions of ECTUN members as a roadblock to the onslaught of the far right

Break right-wing dominance online: The right-wing domination of social media must be broken. In addition to financial resources, we need above all a new culture of communication, not shying away from media-appropriate language and imagery.

Creating sovereignty of interpretation: In addition to substantive positions and organisational issues, trade union renewal must also evaluate our terminology. Take 'justice', for example: in the trade union context, this clearly refers to the fundamental contradiction between capital and labour - for a long time, this was congruent with the generally accepted interpretation. However, shifts in discourse have led to people today applying the term to different relationships of inequality, e.g. those between 'old-established and newcomers'. As a movement, we need clear language and unambiguous terms, otherwise our agitation won't catch on.

Organising is immunising: Scientific findings and practical experience show that organised workers tend to vote less often on the right. This is another reason why we must continue to build up trade union organisational strength.

Creating proximity through usefulness: We must turn our attention to new sectors and target groups and also communicate our expertise more strongly to those who are "left behind". In other words, with SMEs, micro-enterprises and rural economic structures - even if this means drilling hard holes.

Building personal resilience: We need to strengthen the colleagues who have to stand up to the increasingly anti-democratic and anti-union agitation on the ground in the companies. This includes both the content and technical level (argumentation guidelines, rhetoric, etc.) as well as mental strengthening including through community experiences.
